Applications are invited from among serving Tradesman's Assistants of the Local Government Service who wish to be considered for appointment as Painter in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs $15745 \times 260 - 17825 \times 275 - 18925 \times 300 - 19525 \times 325 - 21475 \times 375 - 22225 \times 400 - 23425 \times 525 - 26050 \times 675 - 27400 \times 825 - 28225$ a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 15745 a month.

2. **QUALIFICATIONS**

By selection from among Tradesman's Assistants in the Local Government Service possessing the trade test in painting or hold a certificate in painting from a recognized institution, acceptable to the Local Government Service Commission.

<u>Note:</u>

- 1: The onus for the submission of written evidence of experience/knowledge claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience/knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 2: Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications.
- 3: Applicants are informed that they may be outposted to any sub office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.

3. DUTIES

- 1. To carry out the necessary measurements and calculations of the trade.
- 2. To use and keep in good condition the tools in general use in the trade.
- 3. To remove all paint with soda solution, wash and burn off paint.
- 4. To prepare surfaces for painting.
- 5. To make a putty.
- 6. To sand paper, paint (brush), stop up, flat down with pumice and varnish (brush) and apply putty, paints and varnishes.
- 7. To do ordinary distempering including preparation of walls if required.
- 8. To do simple glazing.
- 9. Must be able to prepare, mix and match paints and to use linseed oil, boiled and raw.
- 10. To ensure good safety conditions while on duty.
- 11. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.
