Applications are invited from qualified candidates who wish to be considered for appointment as Planning and Development Assistant in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 17305 x 260 – 17825 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 – 26050 x 675 – 27400 x 825 – 35650 x 900 – 36550 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 17305 a month.

### II. <u>AGE LIMIT:</u>

Candidates should have reached their <u>18th</u> birthday and unless already in the Local Government Service/Public Service/Approved Service, should not have reached their <u>45th</u> birthday by the closing date for the submission of applications.

#### III. QUALIFICATIONS:

A. A Cambridge Higher School Certificate with passes at Principal Level in at least two subjects including Geometrical and Mechanical Drawing <u>or</u> Design and Technology (Communication) <u>or</u> Design and Technology obtained on one certificate

Passes in at least two subjects including Geometrical and Mechanical Drawing **or** Design and Technology (Communication) **or** Design and Technology obtained on one certificate at the General Certificate of Education 'Advanced Level"

#### <u>0r</u>

An equivalent qualification acceptable to the Local Government Service Commission.

B. Candidates should be computer literate.

### NOTE:

- 1. The onus for the submission of written evidence of experience/knowledge claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of experience/knowledge claimed and Equivalence Certificate, as appropriate, by the closing date.
- 2. Candidates should enclose photocopies of their National Identity Card and academic/technical/professional qualifications.
- 3. Candidates may be requested to submit a character certificate.
- 4. Candidates are informed that they may be outposted to any Sub Office of a Local Authority, and also, with the approval of the appropriate authority, to any Local Authority where their services will be required.

- 4. To report immediately on all cases where action is required in compliance with relevant laws and regulations.
- 5. To advise applicants as regards compliance with relevant guidelines, laws and regulations when submitting applications.
- 6. To assist in the prompt investigation into complaints from members of the public.
- 7. To compile information and assist in the preparation of court cases.
- 8. To use ICT in the performance of his/her duties.
- 9. To perform such duties directly related to the main duties listed above or related to the delivery of the output and results expected from Planning and Development Assistants in the roles ascribed to them according to their postings.
