**VACANCIES FOR THE POST OF WELDER
IN THE LOCAL GOVERNMENT SERVICE**

Applications are invited from among qualified serving Tradesman's Assistant of the Local Government Service who wish to be considered for appointment as Welder in the Local Government Service.

The permanent and pensionable post carries salary in the scale of Rs 15745 x 260 – 17825 x 275 – 18925 x 300 – 19525 x 325 – 21475 x 375 – 22225 x 400 – 23425 x 525 – 26050 x 675 – 27400 x 825 - 28225 a month.

Appointment to the grade in a temporary capacity carries salary at the flat rate of Rs 15745 a month.

2. QUALIFICATIONS

By selection from among Tradesman's Assistants in the Local Government Service possessing the trade test in welding or hold a certificate in welding from a recognized institution, acceptable to the Local Government Service Commission.

Note: Candidates should show proof of all experience claimed.

NOTE:

- 1: *The onus for the submission of written evidence of knowledge/ experience claimed and equivalence of qualification and recognition of institution (if applicable) from the relevant authorities (Higher Education Commission or Mauritius Qualifications Authority) rests on the candidates. Applications will not be considered in case of non-submission of written evidence of knowledge/experience claimed and Equivalence Certificate, as appropriate, by the closing date.*
- 2: *Candidates should enclose photocopies of their National Identity Card and academic/technical qualifications.*
- 3: *Candidates are informed that they may be outposted to any sub office of the Local Authority, and also, with the approval of the appropriate authority, to any other Local Authority where their services will be required.*

3. **DUTIES**

1. To carry out the necessary measurements and calculations of the trade.
2. To use and keep in good condition the tools in general use in the trade.
3. To work from simple drawings or sketches.
4. To carry out in an efficient manner all forms of welding in all thickness of material.
5. To make sound welds in down-hand, oblique, vertical and up hand positions.
6. To do accurate outside and inside welds between plates and between angle irons.
7. To ensure good safety conditions while on duty.
8. Other duties directly related to the main duties listed above or related to the delivery of the output and results expected from incumbents in the roles ascribed to them according to their postings.

4. **MODE OF APPLICATION**

- (i) Qualified candidates should submit their applications on LGSC Form 7a which may be obtained either from the Office of the Local Government Service Commission, Louis Pasteur Street, Forest Side or from any Local Authority.
